FINANCIAL ARRANGEMENTS

- All costs for semen transported into the United States shall be in US Funds.
- The fee for the above stallion for the _____ season shall be \$ _____

Additional mares discounted breeding fees are as follows:

- Cosyland Farms will provide their foal registration kit, including implant with every regular priced breeding fee to one of their stallions (Registered Canadian Mares).
- A non-refundable booking fee of \$100.00 must be paid in advance.
- Daily mare care at Cosyland Farms shall be at the rate of \$8.00 dry/\$9.00 wet.
- Balance of breeding fee plus authorized vet, farrier and other expenses will be due and payable upon release of the mare.
- A pre-breeding deposit of \$200.00 is required when the mare is delivered to Cosyland Farms to cover preliminary vet costs if needed. This amount will be credited towards mare owner's bill.
- Monthly invoices will be forwarded to owners for any mare remaining at Cosyland Farms for more than (30) days and payable upon receipt.
- All artificial insemination, shipping and collection costs will be billed back to the mare owner. The fee for collection of semen of \$160.00 per shipment and the immediate return of the equitainer is charged to the mare owner/lessee. This fee applies to Cosyland Stallions only. With rising costs, this fee is subject to change without notice.
- In the case of loss of the equitainer, the sum of \$500.00 will be billed as well. Late charges for the return of the equitainer will be \$10.00 per day, after 48 hours of last insemination.
- A minimum of 24 hours notice is required for collection of semen.
- An airport delivery charge of 45.00 will apply to all semen being shipped by air or bus. If more than one shipment is being made, the cost will be split among mare owners.

LIVE FOAL GUARANTEE

- If the mare aborted or if the foal dies during the first 24 hours of his life, Cosyland Farms promises to:
 - provide the breeder with a return breeding the following season for the above named mare or an approved substitute.
 - If for any reason the stallion is no longer available, the mare owner can choose a substitute from any of the Cosyland Stallions of equal value
- * A Veterinary certificate may be required to accompany this claim. Further, the mare must have been confirmed in foal by ultrasound within sixty days after last insemination.
- This contract is non-transferrable. If the mare is to be re-bred, she must be bred the breeding season following the date of this signed contract. Deviance from this clause renders this contract null and void.
Note: In extreme cases, Cosyland Farms may approve other arrangements in the event that the mare cannot be re-bred the following season.

MEDICAL REQUIREMENTS

- All mares upon arrival must have a current negative coggins and have hind shoes removed. We also require that the mare be dewormed three weeks prior to her arrival.
- At the discretion of Cosyland Farms and at the mare owner/lessee's expense, further tests may be conducted to determine uterine and follicular activity.
 - Whenever possible, owner's are notified prior of any such tests.

LIABILITY

- During the time that your mare is at Cosyland Farms for breeding (including but not limited to employees thereof, veterinary or farrier) will not be responsible for sickness, disease, astray, theft, death or injury that may be suffered by the mare and/or her foal.

I have read, understand and accept the conditions of this agreement, furthermore this agreement, signed by the respective parties on the dates set forth below constitutes the entire agreement between both parties and same may not be amended or modified, except by a mutual exchange or written instruments, nor may this

agreement or any rights or obligations hereunder be assigned without the prior written consent of both parties.
